Memo: Authorization to pay Fines & Court Costs without appearing in Court**

If you have received a ticket or complaint for any of the offenses listed below, you may enter a written plea of guilty and pay your fine and court costs without personally appearing in court. To do so, you or someone acting on your behalf must present your copy of the traffic ticket/complaint with your signature on the back and payment of the fine and court costs to the Court Clerk at the Traffic Violation Bureau, 105 E. Center St., Sikeston, Missouri, located in the Sikeston City Hall. Office hours are 8:00 a.m. to 4:00 p.m. Monday through Friday. (PAYMENT MUST BE RECEIVED NO LATER THAN 4:00 P.M. THE DAY BEFORE COURT, NO EXCEPTIONS.) No written pleas of guilty or fines will be accepted if you have more than two prior convictions for the same or a similar offense within 2 (two) years preceding the date of the violation.

You have the right to a trial. Signing the plea of guilty and paying the fines and cost will have the same effect as a court judgment. All court proceedings are conducted in the Sikeston Municipal Courtroom, 131 N. New Madrid St., Sikeston, Missouri.

**NOTICE:** Failure to appear on the court date indicated on your ticket or to satisfy your ticket in the manner provided above may result in the issuing of a warrant for your arrest.

**ALL FINES AND COURT COSTS ARE TO BE PAID IN FULL UPON ENTRY OF A PLEA OF GUILTY, OR FINDING OF GUILTY BY THE COURT.**
